FAB WEBSITE & COMMS	The FAB thank the club for helping publicise the launch of the FAB Website. Can we discuss an ongoing set of promotional items (e.g. space in the matchday programme) that regularly directs supporters to the site. The item in the recent matchday programme contained a QR code that linked instead to the AVFC main site. Additionally, can we give consideration to the release of FAB-related news on the AVFC website to coincide with 'slower' news days - i.e. don't release news		
ANNUAL REPORTING	The FAB understands that the club must report to the PL on FAB activity annually. What is the timeline for this, and how will the FAB be consulted and invited to contribute?		
CLINICS	Sent alongside these questions is a proposal and suggested dates for previously discussed FAB matchday Clinics. Several dates are suggested, at both mens and womens home fixtures, with the Holte Pub previously identified as a location. Can we work towards setting dates for the remainder of 2025/26 season?		
AMBASSABOR	Similar to the Clinics mentioned above, can the club update on progress regarding FAB ambassadors, or advise on what is need from FAB to progress this further?

TICKETING	Extension of Military Discount to veterans as well as serving members. The FAB has been in contact with the Military Lions Group, who have requested that the club consider extending the same ticket discounts currently offered to serving members of the Armed Forces, to military Veterans as well.

FAN ENGAGEMENT	Communication and timeline for North Stand Development. How will the North Stand ticket holders feel engaged and excited about the development?		
FAN ENGAGEMENT	Can the club provide an update on the dispatch of Membership packs, and outline plans for 2026/27 to ensure the failures of this season are not repeated? Why was the previously explained dispatch date of December moved to March?		
FAN ENGAGEMENT / CULTURE	Regarding Matchday Experience, can the club look into providing more information on the screens around games - specifically match officials, opposition players, half-time scores - as some supporters may not hear the announcer reading these out.		
FAN ENGAGEMENT / CULTURE	Some feedback regarding bar service at recent Forest home games. A lot of the beers/ciders were off and/or flat, suggesting that the pipes hadn't been maintained correctly during the gap between games. What processes do the club have in place to maintain quality of supplies during periods when there are no games?		
CULTURE	Alongside the FEC Group, can the club outline how the Culture Group will be consulted and included in the North Stand development, in relation to including documentary and heritage assets in the design and look of the new stand.		
CULTURE	Given recent events around the proliferation of sexually explicit/CSAM content on the X/Twitter platform via its Grok AI service, has the club considered its position around remaining on the platform, and has any guidance on this matter been provided by the Premier League?
